POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 29 JULY 2022

At the annual general meeting (the “**AGM**”) of 株式会社ニラク・ジー・シー・ホールディングス NIRAKU GC HOLDINGS, INC.* (the “**Company**”) held on 29 July 2022, voting on all the proposed resolutions as set out in the notice of the AGM dated 6 July 2022 was taken by poll.

POLL RESULTS OF THE AGM

As at the date of the AGM, the total number of issued shares of the Company was 1,195,850,460 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no shares entitling the shareholders of the Company (the “**Shareholders**”) to attend but abstain from voting in favour of any resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”), and there were no Shareholders required to abstain from voting at the AGM pursuant to the Listing Rules. None of the Shareholders have stated their intention in the circular of the Company dated 6 July 2022 (the “**Circular**”) to vote against or to abstain from voting on any of the resolutions proposed at the AGM.

The Company’s Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
