**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 27 JUNE 2019,
APPOINTMENTS OF EXECUTIVE DIRECTORS
AND
INDEPENDENT NON-EXECUTIVE DIRECTOR**

At the annual general meeting (the “**AGM**”) of 株式会社ニラク・ジー・シー・ホールディングス NIRAKU GC HOLDINGS, INC.* (the “**Company**”) held on 27 June 2019, voting on all the proposed resolutions as set out in the notice of the AGM dated 5 June 2019 was taken by poll.

I. POLL RESULTS OF THE AGM

As at the date of the AGM, the total number of issued shares of the Company was 1,195,850,460 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no shares entitling the shareholders of the Company (the “**Shareholders**”) to attend but abstain from voting in favour of any resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”), and there were no Shareholders required to abstain from voting at the AGM pursuant to the Listing Rules. None of the Shareholders have stated their intention in the circular of the Company dated 5 June 2019 (the “**Circular**”) to vote against or to abstain from voting on any of the resolutions proposed at the AGM.

The Company’s Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

The Board announces that Mr. Akinori OHISHI (“**Mr. Ohishi**”) and Mr. Masataka WATANABE (“**Mr. Watanabe**”) have been appointed as executive directors of the Company; and Mr. Kuraji KUTSUWATA (“**Mr. Kutsuwata**”) has been appointed as independent non-executive director of the Company, with effect from 27 June 2019 upon conclusion of the AGM.

The biographical details of Mr. Ohishi, Mr. Watanabe and Mr. Kutsuwata have been disclosed in the Circular. As at date of this announcement, there has been no change of such information.

Save as disclosed in this announcement and the Circular, the Board is not aware of any other matter in relation to the appointments of Mr. Ohishi and Mr. Watanabe as executive directors of the Company, and Mr. Kutsuwata as an independent non-executive director of the Company which is required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules and any other matter that needs to be brought to the attention of the shareholders of the Company.
